**2. ADMINISTRATION**

<b>1.</b>	Only a member of a Club in the State issuing the Organising Permit is permitted to participate in the Activity.
<b>2.</b>	The Club must maintain a register of all persons who enter the Circuit for the activity.
<b>3.</b>	The Age Divisions offered must be in accordance with the <b><i>Karting Australia Appendix 1 – Kart Fun Sessions.</i></b> <ul style="list-style-type: none"> <li>• Cadet 9, Cadet 12 and 4SS Cadet Drivers are permitted on a Track at the same time.</li> <li>• Junior Drivers are not permitted on the Track with any other age division.</li> </ul>

	<ul style="list-style-type: none"> <li>Senior Drivers are not permitted on the Track with any other age division.</li> </ul>
<b>4.</b>	<b>BOOKING</b>
<b>4.1.</b>	The number of positions in the Activity is strictly limited by Government Directions/orders. Accordingly, bookings are essential and are accepted strictly on a 'first come first served' basis. There will be <b>NO ENTRIES ACCEPTED ON THE DAY.</b>
<b>5.</b>	<b>BOOKING FEE:</b> Free
<b>6.</b>	<b>ADMINISTRATION LOCATION</b>
<b>6.1.</b>	Out-grid Shed

### 3. SPECIFIC COVID-19 RESTRICTION AND MITIGATION REQUIREMENTS

<b>1.</b>	<b>PERMITTED AND NON-PERMITTED PERSONS</b>
<b>1.1.</b>	No person who has symptoms consistent with COVID-19 (this includes any fever, respiratory symptoms, shortness of breath, sore throat, cough, lack of smell or fatigue) is permitted to attend the Circuit or participate in the Activity.
<b>1.2.</b>	Any person who starts to feel unwell or to exhibit symptoms of COVID-19 during the Activity must immediately avoid contact with all persons at the Circuit and <b>MUST IMMEDIATELY LEAVE</b> the Circuit.
<b>1.3.</b>	No more than five (5) Essential Karting Personnel may be at the Circuit for the purpose of conducting the Activity. <b>Essential Karting Personnel</b> is defined as: <ul style="list-style-type: none"> <li>Club President, Vice President, Treasurer, Secretary; and</li> <li>Grid Marshal / Track Control Official / Clerk of the Course; and</li> <li>First Aid Attendant; and</li> <li>Administration and Access Control Attendant/s.</li> </ul>
<b>1.4.</b>	<b>Permitted Persons</b> <ul style="list-style-type: none"> <li>A Licensed Driver (Driver) in the COVID-19 Restricted Social Karting activity who has booked their entry in the session plus one other person per kart who must be either: <ul style="list-style-type: none"> <li>The Parent or Legal Guardian of the Driver; or</li> <li>The Participant License Holder for the Driver; or</li> <li>A Mechanic whose sole task it is, is to prepare, adjust, repair the kart as may be required.</li> </ul> </li> <li>A Person who is approved by the Club to supply karting components and provide specialised karting service to any Permitted Persons in attendance at the Activity.</li> </ul>
<b>1.5.</b>	<b>Non-Permitted Persons</b> – there is <b>NO PUBLIC ACCESS and NO SPECTATORS</b> are permitted to be in attendance.
<b>1.6.</b>	All Permitted Persons in attendance must be the holder of a Karting Australia Licence. <ul style="list-style-type: none"> <li>For the avoidance of doubt, this Licence can be a Driver, Participant or Pit Crew Licence.</li> </ul>
<b>1.7.</b>	A Permitted Person attending the Activity must leave the Circuit as soon as they have completed their driving or as soon as their Session is finished, whichever is the sooner.
<b>2.</b>	<b>SOCIAL DISTANCING AND DENSITY REQUIREMENTS</b> (Note – the number chosen in 2.1 <u>must not exceed the maximum number of people permitted to gather under Government Directions.</u> )
<b>2.1.</b>	Essential Karting Personnel and Permitted Persons are not permitted to gather in groups greater than 10.
<b>2.2.</b>	Government prescribed Social Distancing measures must be observed at all times.
<b>2.3.</b>	Permitted Persons <b>MUST NOT</b> park or set their Pit up within 5 metres of another Permitted Person's Pit space.
<b>2.4.</b>	The use by Permitted Persons of any indoor facilities (other than toilets and washrooms) is strictly prohibited.
<b>2.5.</b>	If food service is provided, it must comply with government requirements and be take away only. <ul style="list-style-type: none"> <li>Hand Hygiene must be available at any food service outlet.</li> </ul>
<b>3.</b>	<b>KARTING AUSTRALIA COVID-19 DECLARATION</b>
<b>3.1</b>	<b>Under NO circumstances is ANYONE who has been overseas in the previous 14 days or been in contact with a person who is known to be COVID-19 positive, permitted to attend the Circuit.</b> All Essential Karting Personnel and Permitted Persons <b>MUST</b> : <ul style="list-style-type: none"> <li>Complete and submit the <b><u>Karting Australia COVID-19 Declaration</u></b> at least 24 hours before the commencement time of the Activity; and</li> <li>Forward to the Club Activity Co-Ordinator the confirmation email that you receive after submitting the completed COVID-19 Declaration. <ul style="list-style-type: none"> <li>If the confirmation email is not sent to the Club on time, you will not be granted access to the Circuit.</li> <li>If you have been overseas in the 14 days before the Activity or if you have been in contact with a Covid-19 Positive person, you will not be granted access to the Circuit.</li> </ul> </li> </ul>
<b>4.</b>	<b>HYGIENE FACILITIES - TOILET/WASHROOM FACILITIES and HAND SANITISER</b>
<b>4.1</b>	The Club is required to provide facilities to ensure general and sensible hygiene practices are maintained.
<b>4.2</b>	Toilet and washroom facilities at the Circuit must be open and available for use.

<b>4.3</b>	Washroom facilities must be properly equipped with liquid soap, running water and air hand driers or paper towels. <ul style="list-style-type: none"> <li>The toilets and washroom facilities must be cleaned between Sessions or as otherwise required.</li> </ul>
<b>4.4</b>	It is strongly recommended that Essential Karting Personnel and Permitted Persons bring their own supply of hand sanitiser for use in accordance with government recommendations.
<b>5.</b>	<b>HYGIENE – NON-SHARING OF EQUIPMENT</b>
<b>5.1</b>	The sharing of any equipment including but not limited to: tools, apparel, safety equipment, pens is not permitted.

<b>1.1.</b>	Kart trolleys will be given access to the Track.				
<b>1.2.</b>	Retrieval of karts is at the discretion of the Grid / Track Control Official.				
<b>1.3.</b>	A person must only enter the Track when permitted by an Official and then only when safe to do so.				
<b>2.</b>	<b>ADDITIONAL VENUE REQUIREMENTS</b>				
<b>2.1.</b>	No animals allowed anywhere within the facility.				
<b>2.2.</b>	No unlicensed driving of motor vehicles permitted at the Circuit.
